

SightLife India Activity Report (Summary) April 2016- March 2017


Introduction:

SightLife India along with its partners and key stakeholders continued to build upon its strategy towards elimination of corneal blindness in the country. SightLife, through its various initiatives (building capacity of the human resources at the EBs, improving systems and processes and creating a culture of excellence) worked towards developing the capacity of our key Eye Bank partners as high performing eye banks in the country. The impact of these initiatives have helped to reduce treatable cornea blindness in the country through cornea transplantation. As a result, children returned to classrooms, adults rejoined the workforce and parents were able to take care of their families.

Key activities accomplished from April 1, 2016 to March 2017 are as follows:

Activity 1: Delhi Centralized Hospital Cornea Recovery Project (DCHCRP)

The SightLife India, DCHCRP program continues its progress as a joint program between RP Center, AIIMS, New Delhi; Guru Nanak Eye Centre, Govt. of Delhi and Dr Shroff Charitable Eye Hospital. Its contributions in elimination of corneal blindness is been highlighted under following chart:



In the year 2016-17 various activities were conducted to develop and train EDCs including various training session and workshop, few of them are following:

- I. Three (3) Eye Donation Counselors were promoted to Senior Eye Donation Counselors.
- II. Two (2) new Eye Donation Counselors were hired for the better coverage in Hospitals.
- III. Various Hospital Service activities were organized to gain support of the Hospital Staff, such as:
 - a) Sensitization workshops for nursing staff and doctors,
 - b) Celebration of Nurses Day.
 - c) Celebration of World Sight Day

II. Eye bank association of India and SightLife join hands to train and certify Cornea recovery technicians across India. The objective of the programs was to Maintain, refresh, upgrade and refine their skills. To keep recovery failure rate at a minimum and avoid wastage of recovered tissue.



- III. In the month of October in 2016, there were three sessions organized at different locations, in which 33 technicians participated and 24 got certified. Followings are highlights of the program:
 - a) A two day program, consisted of activity based learning and hands on experience. The participants got an advantage of receiving instant feedback from peers and the faculty.





b) Mr. Govind Hari Joint Secretary of EBAI inaugurated the session at LVPEI followed by Dr. Prashant Garg Director Eye Banking Operations, LVPEI felicitated the participants at the end of the program, Dr. Manisha Garg felicitated participants at Dr. Shroff Charity Hospital and Dr. Jeewan S Tityal at Dr. R P Centre, AIIMS.





c) 24 Eye Recovery Technicians were assessed and trained by SightLife experts at continuing Medical Education organized by Eye Bank Association of India.

IV. Pilot Launch of certification for eye donation counsellors. We have successfully piloted the EDC certification curriculum in collaboration with EBAI. Out of the 12 EDC's who participated from DCHCRP program and Shroff Eye hospital there were 11 who passed with an average percentage of 84% marks. The process of certification included an assessment of EDC's on four parameters (Role play, Behavioral Interview, Written tests and Overall appearance and soft skills). We presented the curriculum to NPCB and they were very appreciative of the design of assessment score cards and the curriculum.





Activity 3: Cornea Distribution Systems





- II. Hit a new milestone: 11 Months with 200+ tissues.
- III. August was the best ever month with 276 placements.
- IV. Participation in KERACON-2016 and DOSCON-2017, helped increase awareness about CDS and enroll interested surgeons.
- V. Supported CDS partner Eye Banks to recover delayed payments from select surgeons.

Activity 4: **Quality**

Quality Certification visits were conducted at **6** Eye Bank partners. These were both Certification and Recertification visits. After the visits, eye banks provided corrective and preventive actions for all the reported audit observations. These were reviewed and followed up by the SL audit team. On resolution and closure of audit observations, Quarterly certification panel meetings were scheduled to arrive at certification decision.

Based on the audit observations and resolution of Corrective Action Preventive actions submitted by the Eye Banks, the following was the certification decision:

Activity 5: Policy and Advocacy

- I. The Policy and Advocacy (P&A) Manager presented on key provisions of the Transplantation Human Organs and Tissue Act (THOTA) at the EBAI- CME Conference in Varanasi. The objective was clarify the ambiguity around certain provisions under THOTA and engage in discussions with eye bank professionals, government stakeholders and corneal surgeons.
- II. P&A team established contact with Deputy Director- Health in Punjab Government to explore future collaboration on developing HCRP in the whole state. He is keen to collaborate and shared the circulars (state government directive) that were issued by Punjab Police for sensitization and action in medico-legal cases (MLC). Another circular that was issued to ensure that the list of Keratoplasty Centres and eye banks are displayed outside all the mortuaries. The Policy and Advocacy team aims to use these circulars to advocate effective collaboration between hospitals and police department in other states.

Following up from the engagement with the Deputy Director- Health in Punjab, the circulars issued by Punjab Police were used as an advocacy tool at PGIMER Chandigarh. Post that development, PGIMER was able to carry out their first recovery of cornea in a MLC.

- III. Expansion of engagement with aligned health care organizations, including Vision 2020 (an advocacy group), and the World Health Organization (WHO) Regional Office that will allow SL to be consulted on policy recommendations at the country and regional level.
- IV. In January, SL served as a technical partner in partnership with Fortis Hospitals, NPCB, National Organ & Tissue Transplant Organization (NOTTO), Eye Bank Association of India (EBAI), Shroff's Charity Eye Hospital and Mohan Foundation, for a workshop on "Revisiting Contraindications to Corneal Blindness."
- V. A comprehensive P&A session was developed and carried out to coach SL partners during SAM. As a consequence, SL partner- Lion's International Eye Bank (LIEB) was keen to send a letter of support to Karnataka police to issue a police circular to direct police to facilitate eye donation in medico-legal cases. P&A team drafted the letter of support and the language for police circular to support LIEB. LIEB has shared the letter and the circular with the state police for them to take immediate action.





Activity 6. Built Operate Transfer (BOT)

With 1,90,000 people suffering from corneal blindness in the state of UP and no eye bank meeting our requirements for new partnerships, there was little hope for correcting the severe shortage in India's most populous state. With the financial support of The Hans Foundation, a partnership was developed with SightLife, King George's Medical University and Sitapur Eye Hospital Trust to develop a world-class eye bank serving not only the people of UP with tissue placements, but all of Asia as a SightLife certified Center of Excellence.








Impact

- With, 1,90,000 people requiring cornea transplants in the state of UP, our rapid growth plan is as follows. A processing fee of Rs. 2,500 per cornea placed for transplant is charged to ensure long-term self-sustainability of eye banking and establish fee for service precedence.



Activity 7: Patient Care Service Line

Follow-up care for corneal transplantation is the key to sustainable surgical outcomes. Different studies have shown that around 50% of the patients who have undergone surgery, drop from post-operative follow-up care within 12 months of surgery, due to myriad reasons related to cost and time. Hence to ensure sustainable surgical outcomes and to bring down post-operative surgeon visit drop-out rate, we are initiating a pilot program in the coming year to better understand barriers and behaviors towards appropriate care. We are happy to share that we have been successfully able to raise Rs. 25 lakhs from Overseas Polymer Pvt. Limited in March 2017 for this new service line.
